**For Dream Mentors Credentialing:**

For DM Credentialing you will be required to have 24 hours of direct contact with a DM certified Master or Professional coach trainer if you desire to apply this course to ICF credentialing requirements. This will be accomplished through group intensive training seminars via webinar and voice-to-voice teleconferencing calls.

If you do desire ICF credentialing you will be required to have one additional hour of mentoring with Coach Candice at the rate of \$100. If you are taking the DM courses and you **do not desire** ICF credentialing then this one hour session is not needed. **Please note at this time all of our courses are exceeding the limit of registered students allowable by ICF, so this information will not apply until we have specialized courses for ICF credentialing only. We will notify you of this when this happens.**

If you do not desire ICF credentialing you will be able to take the first Basic course DMBL101 via webinar with face to face contact hours or via audio mp3 files and a one hour test via test proctor to meet your DM credentialing. There is no cost to take the DMBL 101 Basic course via webinar and conference calling but if you will not be attending this way, you need to sign a waiver and pay a fee of \$250 to take the course through our Distance Learning course format. This includes your audio plus student workbook materials from Dream Mentors (when available) but does not include books from authors used in our program.

Our Distance Learning course format will require you to listen to 30 one hour sessions of audio mp3 files or video (if available) and take a multiple choice exam and/ or oral exam and essay exam with a test proctor to receive your credentials. If you are taking Distance Learning format you will not be allowed to use this course for ICF credentialing.

**Please note that persons who take the DMBL101 course and do not become members will not be Associate Life Coaches. They will receive a certificate that says they completed 30 hours of Basic Biblical Life Coaching at Dream Mentors International. No one will be considered a DM certified coach unless they become a member and continue on to the Advanced Transformational Life Coaching Course**

**Ministry or Client Related Coaching Logs-** You will be required for DM credentialing to provide a minimum of 75 hours of ministry related discipling, teaching or client coaching hours in which you biblically disciplined and or coached individuals or groups within a year. List how many hours you accomplished up to a total of 75 hours for Associate or Professional Life Coaching credentials. If you were the pastor or overseer please identify yourself as such on the log (see attached). ***Pastors and or ordained ministers do not need to fill out this requirement.***

**Letters of Reference-** Please include a total of 3 letters of reference. One letter of reference from your pastor or overseer of the hours you biblically coached individuals at your church or ministry. Also include one client reference and one personal reference.

### **Graduation & Membership:**

Having taken the Basic Biblical Life Coaching Course you **now will be qualified** to become a member of Dream Mentors International. You may graduate from DMBL 101 and not become a member of Dream Mentors. However your certificate will have limited authorization by Dream Mentors. You will be allowed to say you graduated from the basic level course but will not be allowed to teach the materials in individual or group settings. You also will not be included in our Dream Mentors database. Our database enables us to match you up with clients that may need biblical life coaches at the basic level.

**You also must become a member of Dream Mentors if you desire to move into the 30 hour Advanced Transformational Life Coaching Course.** We will not admit anyone into our 30 hour Advanced Transformational Life Coaching Course unless you are a member. Membership means that you are under the covering of DM International to do Biblical and Transformational Life Coaching and that you abide by the DM Ethical Standards of Conduct. As a member you agree to keep your certification current and attend 8 hours of Continuing education credits to continue to be recognized by DM as a certified biblical coach. This will be a yearly requirement. The year will end on December 31.

### **Master Life Coach Training Centers:**

As part of your membership in Dream Mentors you will be assigned to a church that has a Dream Mentors Master Life Coach Training Center in your local area. You will be considered a DM coach that works through this ministry. When Dream Mentors receives calls for those persons seeking life coaches we will send them to a DM Master Life Coach Training Center located at a local church outreach first where your Head Master Life Coach trainer will call you to see if you are interested in meeting with a particular client. The meetings with clients can be in person, via phone, or webinar from your home but you must be under the covering of a DM Master Life Coach Training Center that we have assigned you to.

### **Continuing Education Credits (CEC):**

In order to keep your certification/membership current, you will be required to complete an eight-hour continuing education course through Dream Mentors before renewal at the end of each calendar year ending on December 31.

### **DM Training for Non-Denominational Biblical Coaching:**

As part of the DM Coach Training we will be considerate of all Christian faith traditions and our coaching will be initiated from a non-denominational perspective. This means we will focus in our DM biblical group training sessions on meeting the needs of clients from all faith perspectives. DM prohibits any and all forms of discrimination and harassment based on race, color, sex, religion, national origin, marital status, age, homelessness, or disability or other basis prohibited by law in any of its programs, services, activities or employment.

- We believe in the verbal inspiration of the Bible. (II Tim. 3:15-16, I Peter 2:2)

- We believe in one God eternally existing in three persons; namely, the Father, Son, and Holy Spirit. (Deut. 6:4, Mark 12:29, Matt. 28:19)
- We believe that Jesus Christ is the only begotten Son of the Father, conceived of the Holy Spirit and born of the Virgin Mary.(Isaiah 7:14, Matt. 1:18, Luke 1:26-35)
- We believe that all have sinned and come short of the glory of God and that repentance is commanded of God for all and necessary for forgiveness of sins. (Romans 3:23)
- We believe the justification, regeneration and the new birth are wrought by faith in the Blood of Jesus Christ. (Luke 24:47; Romans 10:13)
- We believe in sanctification subsequent to the new birth, through faith in the blood of Christ; through the Word, and by the Holy Spirit. (Romans 5:2; I Cor. 1:30; I Thess. 4:3, Hebrews 13:12; I John 1:9)
- We believe divine healing is provided for all in the atonement (Psalm 103:3, Isaiah 53:4-5, Matt. 8:17, James 5:14-16; I Peter 2:24)

These are the basic tenets of the non-denominational perspective that you will receive as a student of Dream Mentors International. While you are a certified Associate, Professional, or Master Life Coach with Dream Mentors you will be required to adhere to these faith tenets.

**Biblical Coaching Ethics**

As biblical coaches, we will be sensitive to the needs of all Christian faith perspectives that need our services but we do not infringe our specific doctrinal beliefs pertinent to our faith traditions on others.

For those questions that client’s may have that are doctrinal in nature, as an ethically biblical coach you are to refer them to their pastors for greater understanding.

I will have met the first requirement when I finish my 30 hour DMBL101 Course via webinar. However, I still must complete a one hour mentoring session with Coach Candice if I desire to meet this requirement. If I do not have the one hour session my involvement with this DMBL101 course will not enable me to meet ICF requirements for course credentialing should Dream Mentors courses become an Approved Coach Specific Training (ACSTH ) course with ICF.

I am also aware that since DM does not charge for its DMBL101 course, if I desire to meet these ICF requirements should DM courses be approved, I will need to meet with Coach Candice Smithyman for up to one hour of mentoring. This will be at the fee of \$100 for one hour. However, please note that at this time all of the Dream Mentors webinars have exceeded the personnel limit allowed by ICF for credentialing so until we put limits on our student attendance our classes are not permitted to be accepted ICF courses. For future courses we will place these limits and will notify you of that change when necessary.
